TOPIC:CLOSED FORMULARY (DRAFT INFORMAL RULES)

The Division of Workers' Compensation has released draft rules relating to the development of a closed formulary. These rules incorporate by reference certain exclusions contained in the formulary found in the Official Disability Guidelines (ODG).

The Texas Department of Insurance, Division of Workers' Compensation, (TDI-DWC) has prepared a working draft of rules concerning Pharmaceutical Benefits, which include a Pharmacy Closed Formulary. These draft rules are to be proposed in order to implement the provisions of section 3.090 of HB 7, 79th Legislature, Regular Session, which amended Labor Code Chapter 408 (Workers' Compensation Benefits).

TDI-DWC invites your input on the working draft rules. This is an informal posting and not a publication for rulemaking as required by Chapter 2001 of the Government Code.
